The Board of Education of District No. 119, St. Clair County, Illinois, met in the library, Belle Valley School District, 2465 Amann Drive, Belleville, Illinois, in said District at 7:00 P.M. on Tuesday, February 16, 2021.

President Kunz called the meeting to order. The roll was called and the following members were present: Mrs. Kunz, Mrs. Collins, Mrs. Winn, Mrs. Miller, Jeramy Radliff, and Dr. Winfield. Those absent: Mr. Warner.

The Board of Education and others in attendance recited the Pledge of Allegiance.

President Kunz recommended adopting the board agenda. Mrs. Collins moved to adopt the board agenda. Mrs. Miller seconded the motion. Members voting aye on roll call: Mrs. Kunz, Mrs. Collins, Mrs. Winn, Mrs. Miller, Mr. Radliff, and Dr. Winfield. Nays none, motion carried.

President Kunz recognized the remote visitors and asked if there were any public comments. Becky Stevens and Alicia Augustine, Belle Valley Education Association Co-Presidents, expressed the teachers are very appreciative of being able to obtain the COVID vaccine.

The Board of Education acknowledged OPAA's monthly food service report.

Principal Leib reported parent-teacher conferences took place via google meets and telephone for students on the retention list. Some of these students will be returning to inperson learning this week.

Principal Callahan reported she has been performing teacher observations.

Kourtne Boose, Special Education Coordinator, reported that due to projected early childhood numbers, the District may need only one (1) early childhood teacher and an additional Kindergarten/1st grade cross-categorical, self-contained life skills/functional skills teacher.

Supt. Gale reported the Illinois Assessment for Readiness (IAR testing) is scheduled to start March 15th. Approximately 700 superintendents have signed a petition requesting a waiver of state testing for this school year. He informed the solar array is up and running. He included an information attachment for the board packet of the 2021 Illinois 5Essentials Survey. He continues to provide weekly COVID reports. He informed Belle Valley School District is one

of the first schools to be randomly selected for teachers and staff to receive their first COVID-19 vaccination shot Saturday, February 21st. He informed the District should plan on continuing remote learning for next school year because COVID-19 vaccination for children under the age of 16 is not expected until the fall of 2021. He reminded the Board that the District has an approved E-learning plan. The District can use this plan instead of snow days.
