BOARD POLICY:

Expulsion – The Board of Education takes action to exclude a student from the educational setting for a period of time not to exceed (2) calendar years.

1. Only the School Board has the authority to expel a student.
2. A student may not be expelled until after a hearing.
3. A student may be suspended for no more than ten (10) days, while waiting for the Board hearing.
4. No expulsion will occur unless recommended by the Superintendent or designee and ordered in Resolution by the Board.

RESOLUTION # 05032016: (RC)

OPTION #1 (Requires parental approval)

Student K would receive two (2) years expulsion held in abeyance provided student K attend safe school and adhere to the following three (3) conditions:

1. Student K must attend school and have no more than eight (8) unexcused absences per year or her expulsion becomes effective immediately.
2. Student K must attend school and not get dismissed from Safe School for disciplinary reasons or her expulsion becomes effective immediately.
3. Bus transportation to and from Safe School will be provided by the district; as well as tuition.

OPTION #2 (To be enacted should parents not agree with option #1)

Student K would receive two (2) years expulsion and then return to Belle Valley. Placement of student K upon completion of the two years will be determined by Belle Valley Administration.
