Gale discussed changing the bus drop off and installing temporary speed bumps in the circle drive. The circle drive will be used for parent drop off.

Mrs. McKay discussed the tentative district budget for the 2018-2019 school year.

Supt. Gale discussed Health, Life, Safety items. The ballfield resurfacing was not allowed as a Health, Life, Safety item. The compressor above the principal's office needs to be replaced at an estimated cost of \$7,000 and will be submitted as a Health, Life, Safety amendment. There is a plumbing problem with sediment build up in a pipe under a girder. Bergman Roscow estimated cost is \$2,810. The concrete bid from Yarber Concrete for the front entrance with a rubber spacer was \$11,850. Supt. Gale discussed a second playground bid for the Pre K playground and repairs to the rear playground surface. Supt. Gale discussed a repair or replacement of a 750 gallon water tank. The tank is leaking and a new water tank has been ordered.

Mr. Warner moved to approve the concrete bid from Yarber Concrete for the front entrance with a rubber spacer for \$11,850. Mrs. Miller seconded the motion. Members voting aye on roll call: Mrs. Kunz, Mrs. Miller, Mr. Radliff, Mr. Warner, Dr. Winfield, and Mrs. Collins. Nays none, motion carried.
